Fund Objectives

Japan Smaller Capitalization Fund, Inc. ("JOF" or the "Fund") is a non-diversified, closed-end management investment company listed on the New York Stock Exchange. The Fund's investment objective is to provide shareholders with long-term capital appreciation and to invest, under normal circumstances, at least 80% of its total assets in smaller capitalization Japanese equity securities traded on the Tokyo, Nagoya, and JASDAQ Stock Exchanges, the Mothers, Centex Markets, and other indices

or markets determined by the investment adviser to be appropriate indices or markets for smaller capitalization companies in Japan. Nomura Asset Management U.S.A. Inc. has served as the Fund's Manager since the Fund's inception in 1990. Nomura Asset Management Co., Ltd. has served as the Fund's Investment Adviser since the Fund's inception. The Manager and Investment Adviser are subsidiaries of Nomura Holdings, Inc. and affiliates of Nomura Securities Co., Ltd., Tokyo, Japan.

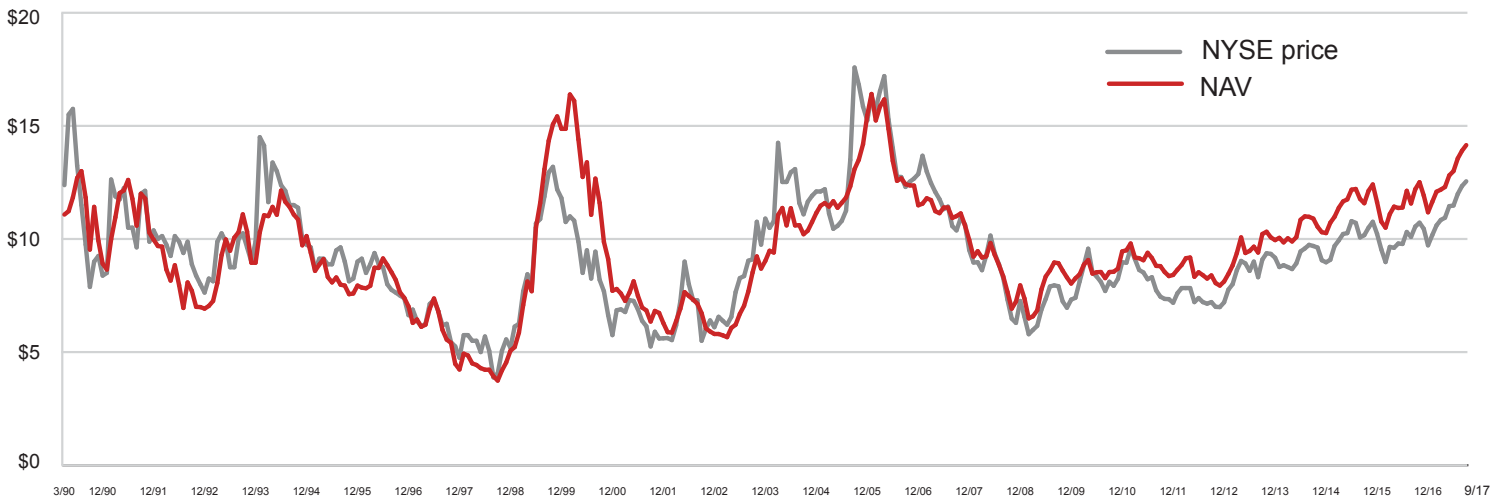

Net Asset Value Since Inception¹ vs. NYSE Closing Price (as of 9/30/2017)



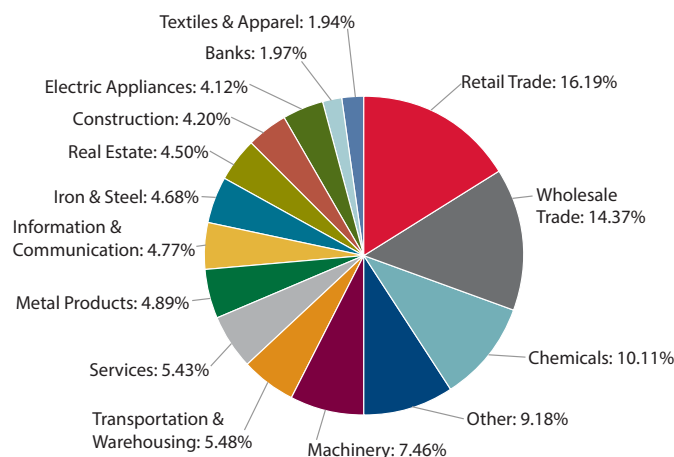

Manager's Commentary

The Japan equity market enjoyed a sharp rebound as the TOPIX index gained 3.55% in September 2017, lifting the market return for the 2Q17 period to 3.90%. Despite the geopolitical overhang surrounding North Korea, healthy corporate earnings prospects amid supportive business conditions, including steady natural resource prices and foreign exchange rates, underpinned the steady performance of Japanese equities this month.

Economic data was mostly in line with previous expectations and continued to suggest steady production activity supported by global demand. The Production Index

rose 2.1% (mom) in August. There seems to be a gradual turnaround in the prolonged domestic demand weakness as household consumption increased by 0.6% (yoy) in August.

Prime Minister Abe called a surprise snap general election for the House of Representatives at the end of September, possibly to capitalize on a recent recovery in cabinet approval ratings together with the current disarray in the main opposition party. However, the possible realignment of the opposition parties around the popular Tokyo governor Yuriko Koike now makes the election outcome much less predictable.

During the review month, cyclical sectors led the market rally and the Automobiles sector outperformed in response to solid earnings results, which seemed to have eased the concerns over flattening passenger car demand in the US and China, along with the growth of electric vehicles producers. The sector performance this month allowed them to catch up with the returns in other manufacturing sectors.
