Fund Objectives

Japan Smaller Capitalization Fund, Inc. ("JOF" or the "Fund") is a non-diversified, closed-end management investment company listed on the New York Stock Exchange. The Fund's investment objective is to provide shareholders with long-term capital appreciation and to invest, under normal circumstances, at least 80% of its total assets in smaller capitalization Japanese equity securities traded on the Tokyo, Nagoya, and JASDAQ Stock Exchanges, the Mothers, Centex Markets, and other indices

or markets determined by the investment adviser to be appropriate indices or markets for smaller capitalization companies in Japan. Nomura Asset Management U.S.A. Inc. has served as the Fund's Manager since the Fund's inception in 1990. Nomura Asset Management Co., Ltd. has served as the Fund's Investment Adviser since the Fund's inception. The Manager and Investment Adviser are subsidiaries of Nomura Holdings, Inc. and affiliates of Nomura Securities Co., Ltd., Tokyo, Japan.



Net Asset Value Since Inception¹ vs. NYSE Closing Price (as of 11/30/2017)





Manager's Commentary

The TOPIX Index extended its rally, gaining 1.48% in November 2017. Although some cyclical stocks faced profit taking, the steady overall earnings prospects of Japanese companies seems to underpin the equity market.

There was only minor variation between sector returns as outperformers met profit taking toward the month-end. Despite the robust earnings results, cyclical sectors including Electronics, Capital Goods, and Commodities recorded mediocre performances. Consumption stocks recouped some past underperformance,

and became the strongest sector during November.

Macroeconomic figures were moderate but positive as the Industrial Production Index grew by 0.5% (Oct, MOM), but failed to match the consensus +1.8%. Domestic demand also shows a slow recovery. Real household consumption was unchanged (YOY) for Oct 2017. In contrast to the flattened macroeconomic conditions, Japanese companies have announced robust earnings results from late October. Aggregate recurring profits for the first half of fiscal year 2017 of those listed on the

Tokyo Stock Exchange 1st section grew by 18.4% (YOY). In particular, manufacturing companies drove the positive results, with recurring profit growth of 35.9% for the same period. Japanese manufacturers have focused on profitability, resulting in improved profit margins amid tailwinds from healthy global demand growth and stabilizing foreign exchange rates.
