Fund Objectives

Japan Smaller Capitalization Fund, Inc. ("JOF" or the "Fund") is a non-diversified, closed-end management investment company listed on the New York Stock Exchange. The Fund's investment objective is to provide shareholders with long-term capital appreciation and to invest, under normal circumstances, at least 80% of its total assets in smaller capitalization Japanese equity securities traded on the Tokyo, Nagoya, and JASDAQ Stock Exchanges, the Mothers, Centex Markets, and other indices

or markets determined by the investment adviser to be appropriate indices or markets for smaller capitalization companies in Japan. Nomura Asset Management U.S.A. Inc. has served as the Fund's Manager since the Fund's inception in 1990. Nomura Asset Management Co., Ltd. has served as the Fund's Investment Adviser since the Fund's inception. The Manager and Investment Adviser are subsidiaries of Nomura Holdings, Inc. and affiliates of Nomura Securities Co., Ltd., Tokyo, Japan.

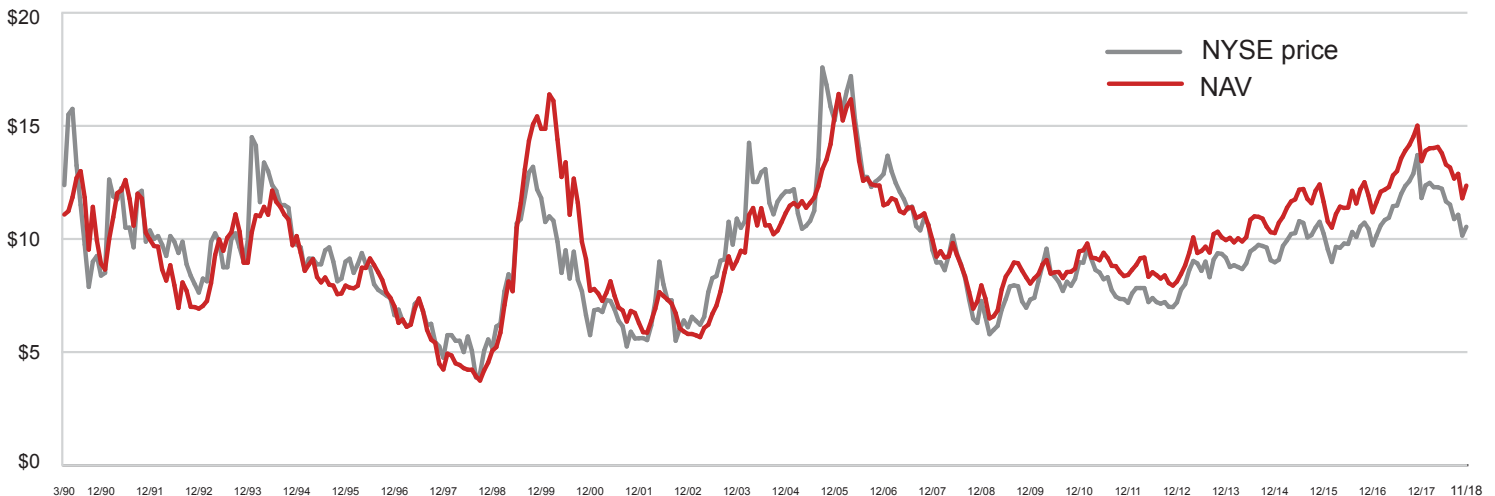

Net Asset Value Since Inception¹ vs. NYSE Closing Price (as of 11/30/2018)



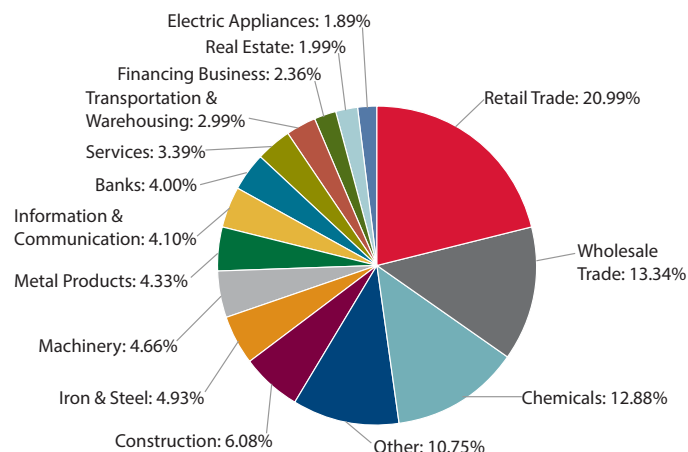

Manager's Commentary

Following the major sell off in October, Japan's equity markets rebounded this month and the TOPIX Index returned 1.30% in November 2018. Trade tensions between China and the US remain unresolved but a summit meeting at the beginning of December between the two countries appeared to alleviate the near term escalation worries. Concerns about the slowing global economic growth also persisted. Markets saw some relief however, when FRB Chairman Jerome Powell hinted that policy interest rates could be held steady for a while.

Latest data suggests that Japan's macro-economic conditions might be recovering from the series of natural disasters in August and September. Industrial Production

increased by 2.9% (MOM) in October 2018 and the analysis of forecasts suggests the recovery trend could be sustained towards the end of the year. Domestic demand also advanced steadily, with seasonally adjusted retail sales growth of 1.2% (MOM) in October 2018. The inbound tourism trend turned positive again last month. Meanwhile, the Japanese government released an interim plan to alleviate the negative impact of the consumption tax hike scheduled in October 2019, which was a relief to some investors given that countermeasures in the past were not sufficient to prevent a slump in demand following the tax hikes.

Defensive sectors led the recovery in the equity market in November 2018. The

Infrastructure and Consumption sectors led the market with a sharp rebound and recouped their losses in the previous month. Recent confirmation of stable domestic demand conditions and quarterly corporate earnings results supported the recovery in the share performance of these sectors. On the other hand, Financials detracted from the market return as the prospect of a delayed US rate hike seemed to be associated with a possible decline in bank lending margins. Commodities also weakened along with the drop in crude oil prices.
