Fund Objectives

**Japan Smaller Capitalization Fund, Inc. ("JOF" or the "Fund")** is a non-diversified, closed-end management investment company listed on the New York Stock Exchange ("NYSE"). The Fund's investment objective is to provide shareholders with long-term capital appreciation and to invest, under normal circumstances, at least 80% of its total assets in smaller capitalization Japanese equity securities traded on the Tokyo, Nagoya, and JASDAQ Stock Exchanges, the Mothers, Centex Markets, and other indices

or markets determined by the investment adviser to be appropriate indices or markets for smaller capitalization companies in Japan. Nomura Asset Management U.S.A. Inc. has served as the Fund's Manager since the Fund's inception in 1990. Nomura Asset Management Co., Ltd. has served as the Fund's Investment Adviser since the Fund's inception. The Manager and Investment Adviser are subsidiaries of Nomura Holdings, Inc. and affiliates of Nomura Securities Co., Ltd., Tokyo, Japan.

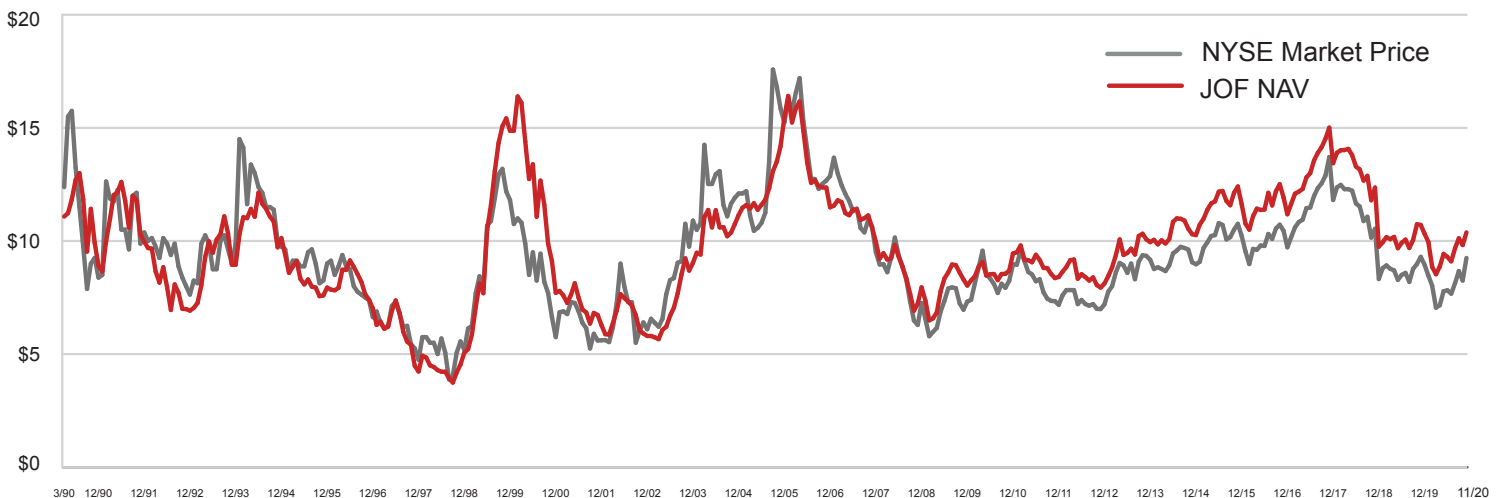

JOF NAV versus NYSE Market Price



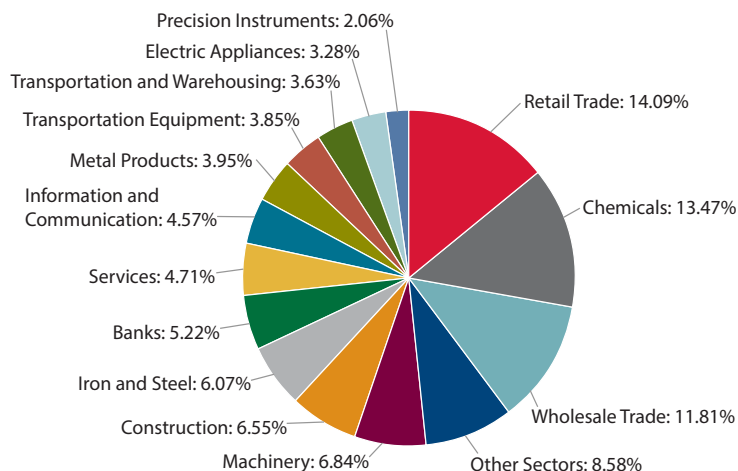

## Market Commentary

Looking at the relative performance of various market indexes since September 2020, it seems clear that the “value versus growth” debate over equity investment performance will continue to rage. Evidence from the recent performance of large-cap funds indicates that a rotation towards value-stocks may be upon us finally. Experience has shown that small-cap stock selection trends often tend to follow some way behind the large-cap market. As such, we believe a valuation adjustment is possible in the near term.

Despite the uncertainties ahead and risk factors that are overshadowing the market right now – the resurgent Covid-19 pandemic and the economic trends – long-term interest rates can be considered the most relevant factor in terms of the relative performance between value stocks versus growth stocks. We believe value anomalies will be resolved when long-term interest rates rise. In particular, we think shifts in worldwide fiscal policy as well as US long-term interest rates are crucial. It seems that several major economies may be shifting

emphasis away from monetary policy support and towards expansionary fiscal policy.

Rather than attempting to speculate on an uncertain outlook, we believe it is most important to invest in stocks that are trading at an appropriate or attractive valuation level. We will maintain our consistent investment process, which focusses on differentiating factors such as competitiveness and management quality.
