Fund Objectives

**Japan Smaller Capitalization Fund, Inc. ("JOF" or the "Fund")** is a non-diversified, closed-end management investment company listed on the New York Stock Exchange ("NYSE"). The Fund's investment objective is to provide shareholders with long-term capital appreciation and to invest, under normal circumstances, at least 80% of its total assets in smaller capitalization Japanese equity securities traded on the Tokyo, Nagoya, and JASDAQ Stock Exchanges, the Mothers, Centex Markets, and other indices

or markets determined by the investment adviser to be appropriate indices or markets for smaller capitalization companies in Japan. Nomura Asset Management U.S.A. Inc. has served as the Fund's Manager since the Fund's inception in 1990. Nomura Asset Management Co., Ltd. has served as the Fund's Investment Adviser since the Fund's inception. The Manager and Investment Adviser are subsidiaries of Nomura Holdings, Inc. and affiliates of Nomura Securities Co., Ltd., Tokyo, Japan.

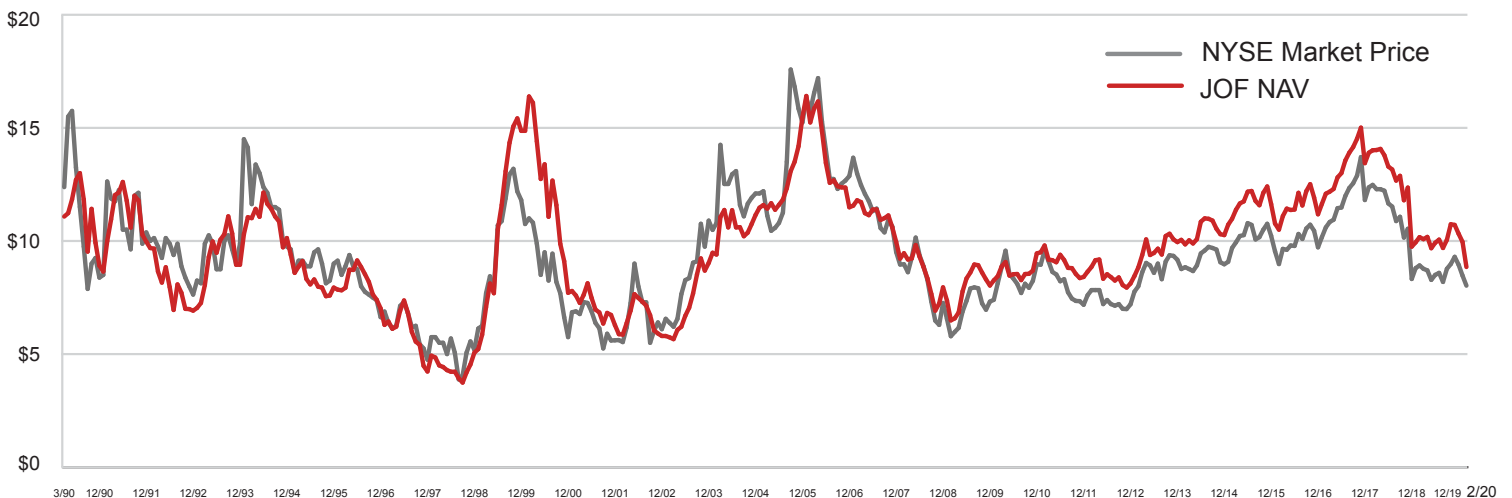

JOF NAV versus NYSE Market Price



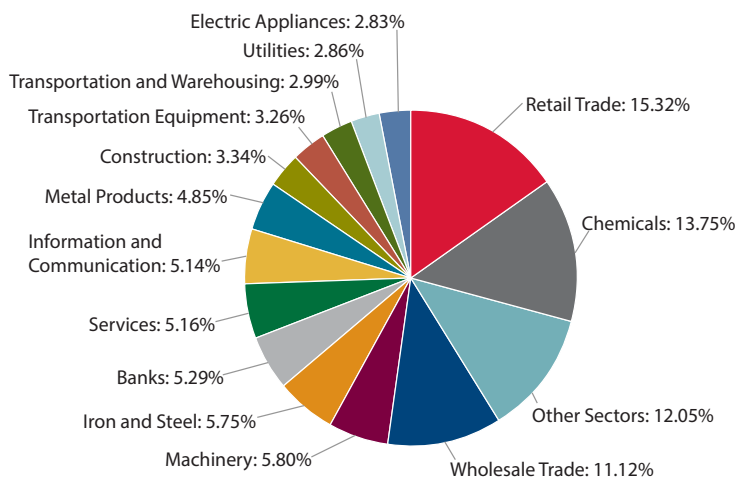

## Market Commentary

The Japanese small-cap equity market fell dramatically in February 2020, while the Russell/Nomura Small Cap Index has underperformed relative to the Tokyo Price Index ("TOPIX") by 5 percentage points since the beginning of the year. While the coronavirus spread has undermined market sentiment, its impact has been even more damaging for Japanese small-

cap equities, which tend to have lower liquidity. In February 2020, there was a remarkably steep sell-off among the high-beta small-cap stocks.

While growth stocks had outperformed value stocks in January 2020, this situation was reversed in February 2020. Such return reversal events are likely to continue for a while.

Similar to the market sell off conditions surrounding the Bankruptcy of Lehman Brothers in 2008 and The Great East Japan Earthquake in 2011, and especially during such periods of crisis and turbulent markets, we believe investors who invest in equities at such discounted levels will be rewarded over the longer-term.
